

**PROCLAMATION OF REV. EMMANUEL  
OSHOFFA AS PASTOR OF CELESTIAL CHURCH  
OF CHRIST WORLDWIDE IN SUCCESSION TO  
REV. PHILIP HUNSU AJOSE**

Whereas the constitution of Celestial Church of Christ provides that the successor to the office of Pastor shall be chosen by the Holy Spirit of God and revealed by the erstwhile incumbent of the office of Pastor;

And whereas the erstwhile incumbent, Rev. Philip Hunsu Ajose, did not reveal his successor before his transition on 2<sup>nd</sup> March 2001;

And whereas the constitution of Celestial Church of Christ further provides that in the event of such an impasse, the remaining members of the Pastor - in - Council shall be constituted into an electoral college for the purpose of electing a successor to the post of Pastor;

And whereas in obedience to spiritual injunction, members of the Celestial Church of Christ worldwide convened at the Holy land, Celestial City, Imeko for two days of special prayers with fasting on September 28<sup>th</sup> and 29<sup>th</sup> 2002;

And whereas a Committee of prophets and prophetesses was mandated to screen the forty-three spiritual messages delivered and recorded during the two-day special convention of prayers with fasting;

And whereas the remaining members of the Pastor- in - Council duly constituted into an electoral College for the purpose of appointing a successor as Pastor to Rev. Philip Hunsu Ajose met on Saturday 21<sup>st</sup> December, 2002, Sunday 22<sup>nd</sup> December 2002 and Tuesday 24<sup>th</sup> December 2002, and received information from the Committee of prophets and prophetesses of God's clear choice of Superior Evangelist Emmanuel Oshoffa as the successor to the office of Pastor;

And whereas in consequence the Pastor - in Council unanimously appointed him as Pastor;

It is hereby proclaimed that Superior Evangelist Emmanuel Oshoffa is hereby appointed Pastor of Celestial Church of Christ worldwide to the glory of God and of

His Son our Lord and Saviour Jesus Christ and he shall henceforth be addressed as


















